TO LISTEN TO JUDGES COMMENTARY: Each director should be set up with an account through CompetitionSuite. This is the **ONLY WAY** to receive judge's commentary for any WGI event. Instructions to do this are available [here](#).

INSPECTION: Located by the ready line.

TARPS: No unfolded performance tarps allowed in parking lots. You may use a practice tarp and it must be labeled "Practice." Violation of this policy is subject to penalty.

WARM-UP AREA: All warm ups will be outside unless inclement weather. A rain schedule is included in this packet and there will be tents available for warm up if inclement weather is expected. All maps are in this packet. Ensembles should to ensemble check in report one hour prior to performance time.

PRELIM SCORES: Posted in the lobby area by the concession area.

CRITIQUE: You MUST sign up for your critique time upon check in.

RECAPS AND FINALS INFO: Pick up 20 minutes after conclusion of your class prelims at the announcer's table.

FINALS SCHEDULE: The finals schedule will be made available to you after it has been determined.

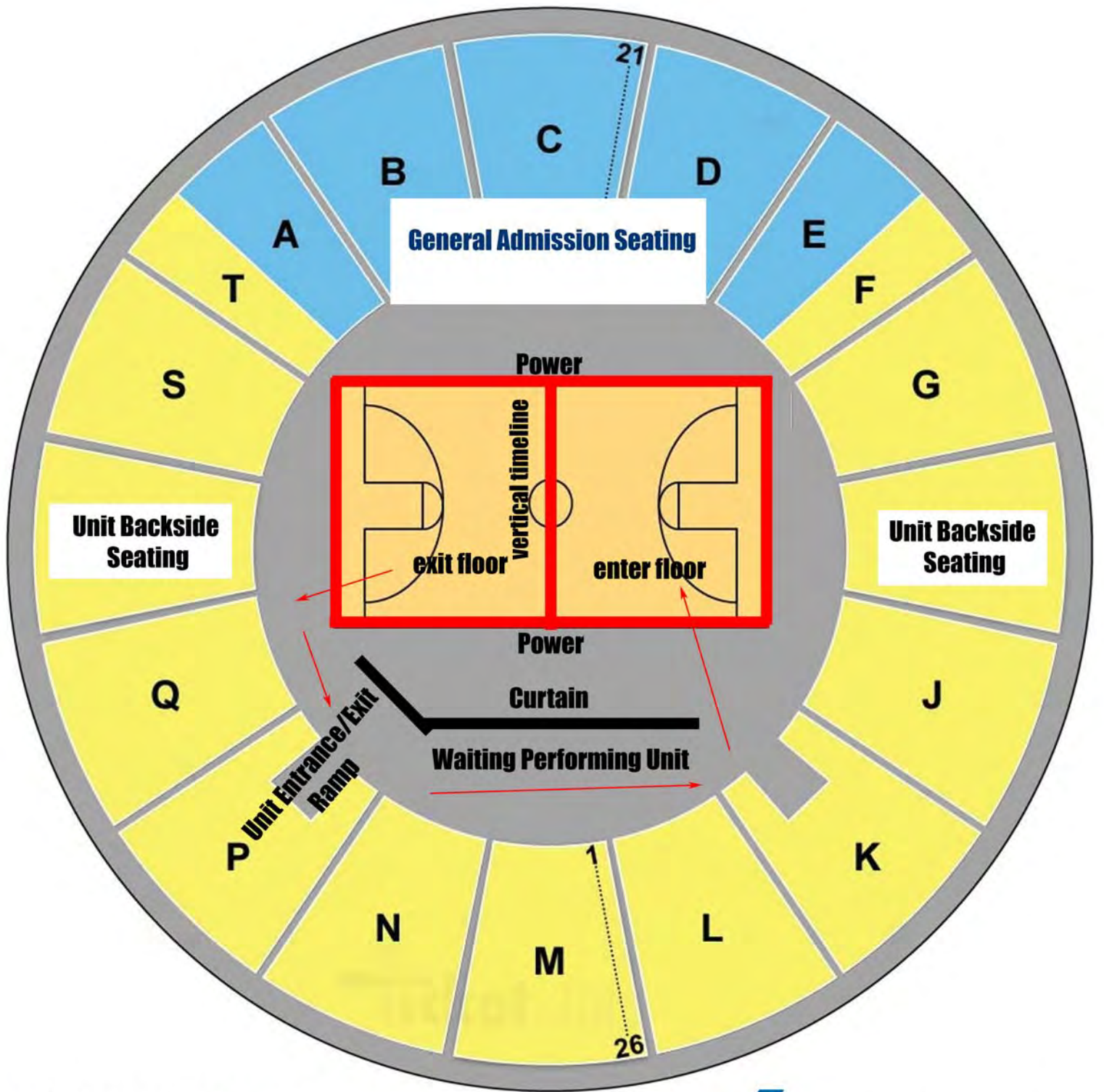

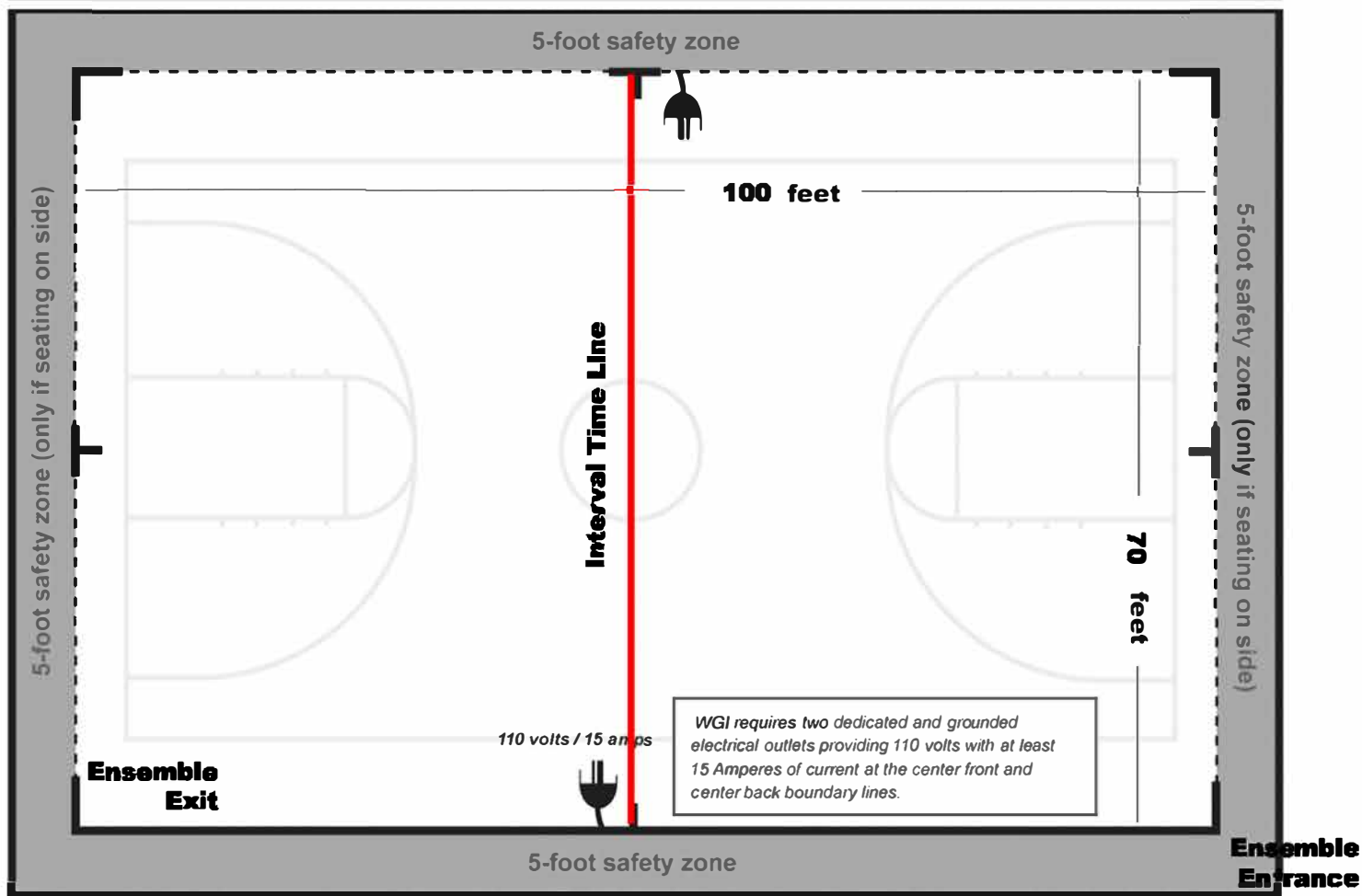

All WGI contest sites must have a minimum of seventy by one hundred feet (70' x 100') to accommodate a "safety zone" of five (5) feet from any spectator seating. If no spectators are seated on the left and right sides, then the safety zone will be eliminated on the left and right sides of the competition area and extend to the wall.

The "competition area" at this event measures 70'X100'. All performing groups must be prepared to perform within that area. Floors (tarps) may not extend into the safety zones per rules found in the WGI Adjudication Manual and Rulebook
