Performer(s) / Group / Team and / or Club

Performer(s) or Music Producer making the Mix



Edit and adapt an existing song

Including combining the adapted song into a mix with voiceovers, sound effects, beats

Performer(s) performing to the Mix



Practise alone



Set choreography to the mix



Make copies of the mix for training and preparation.



Perform the routine in public with the mix: practice & competition





TRADITIONAL LICENSING PROCESS

Traditionally, all of these rights need to be cleared directly with the rightsholders.

Research Who Owns the Rights

Contact Them Negotiate Fee Permission Denied or Granted



You need permissions from








HOW WE MAKE IT WORK

Rights Management Database



Ingests & matches music industry data (DDEX, CWR, Excel).

Matches Master and Publishing Rights.


Uploads 100% fully cleared music.

2 Licensing Platform



A marketplace for teams to instantly license music at: \$10, \$15, \$20 or \$25 per track, per mix for 1 year.

License Verification System




Ingests teams music mixes.


