Ticket prices include a \$2 arena ticketing fee.

Each ensemble will receive ten (10) staff passes unless a PLUS pass was purchased. A PLUS pass allows an additional seven (7) staff for a total of seventeen (17). PLUS passes are **NOT** available for purchase at the event.

If you wish to purchase additional tickets, they will be available at the spectator box office **ONLY**. Please make all checks payable to WGI. If you plan on purchasing tickets for both prelims and finals, it would be wise to bring two separate checks. Ensembles can purchase combo tickets which would allow additional staff entry for both days.

Per arena guidelines all backpacks, purses, etc. will be searched prior to entry.



BB&T Arena Prohibited Items:

- Aerosol Cans
- Alcohol, drugs, illegal substances or any paraphernalia associated with drug use
- Animals
- Audio/Video recorders
- Backpacks
- Bags larger than 14"x14"x6"
- Balloons
- Cans, bottles coolers or other similar containers
- Fireworks
- Flags, signs, banners, with poles
- Hover boards
- Laser pens/pointers
- Noisemakers such as air horns or whistles
- Outside food or drinks
- Tripods, monopods or other professional photography equipment
- Selfie Sticks
- Weapons of any type including, chains, knives, firearms and spiked jewelry
- **Other items deemed unacceptable by event/building management**

SECURITY SCREENING PROCEDURES – GENERAL PUBLIC

- Please plan to arrive early
- All guests and employees are subject to search upon entry.
- Security will perform visual inspections and bag checks using dowels at all entrance points for the particular event, including the employee entrance and the back of house loading dock entrance.
- Event attendees will be screened at the entrances, looking for above prohibited items
- Bags will be checked
- Medical bags exceeding 14"x14"x6" will be tagged with a bright colored wristband to indicate bag has been inspected.
- Diaper bags exceeding 14"x14"x6" will be tagged with a bright colored wristband to indicate bag has been inspected.
- Patrons have the option of discarding prohibited items at entrance point or taking the items back to their vehicle.

All “Primary” and “Secondary” contacts have been connected as Administrators to your group in Competition Suite using their **primary email address on file with the WGI office**.

Only Administrators can approve other staff members to have access to the judge recordings under the **Staff Management** area. Staff members who were associated with your group in 2018 can be approved by simply clicking “Approve Staff Member” to the right of their name. If you wish for other instructors to have access to judge commentary for this group, add other members by following the steps below:

Adding Staff Members

1. Log into your Competition Suite account and select the group you want to manage.
2. Click on **Administration**. *If Administration is disabled, you are not an administrator of your group. Please contact the group’s administrator or WGI office.*
3. Click on **Staff Management**
4. Enter your staff member’s email address and click **Add Staff Member**.
5. If appropriate, change the staff member to an administrator.
6. Repeat step #4 and #5 for all staff members.

2. Make sure your group Administrator has added/or approved you to have access to the judge recordings.

All WGI contest sites must have a minimum of seventy by one hundred feet (70' x 100') to accommodate a "safety zone" of five (5) feet from any spectator seating. If no spectators are seated on the left and right sides, then the safety zone will be eliminated on the left and right sides of the competition area and extend to the wall.

The "competition area" at this event measures 106'X72. All performing groups must be prepared to perform within that area. Floors (tarps) may not extend into the safety zones per rules found in the WGI Adjudication Manual and Rulebook.
